COMMISSION DECISION

of 20 April 1995

relating to the updating of the list of entities covered by Council Directive 90/547/EEC on the transit of electricity through transmission grids

(95/162/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Directive 90/547/EEC of 29 October 1990 on the transit of electricity through transmission grids⁽¹⁾, as last amended by the Act of Accession of Austria, Finland and Sweden, and in particular Article 2 (2) thereof,

After consultation with the Member State concerned,

Whereas the high-voltage electricity transmission grids in the Member States and the entities responsible for them are shown in the Annex to Directive 90/547/EEC;

Whereas the entities having a high-voltage grid should be included in the list; whereas that list should therefore be amended accordingly, by adding Edison Termoelectrica and Edison, Italy,

HAS ADOPTED THIS DECISION:

Article 1

The Annex to Directive 90/547/EEC is replaced by the text shown in the Annex to this Decision.

Article 2

Italy shall bring into force the requisite laws, regulations and administrative provisions by 30 June 1995. It shall forthwith inform the Commission thereof.

Article 3

This Decision is addressed to the Member States.
