## **COMMISSION REGULATION (EC) No 292/95**

of 13 February 1995

amending Regulation (EC) No 2993/94 fixing the aid for the supply of milk products to the Canary Islands under the arrangements provided for in Articles 2 to 4 of Council Regulation (EEC) No 1601/92

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 1601/92 of 15 June 1992 concerning specific measures for the Canary Islands with regard to certain agricultural products (1), as last amended by the Act of Accession of Austria, Finland and Sweden to the European Union (2), and in particular Article 3 (4) thereof,

Whereas Commission Regulation (EC) No 2790/94 (3), as amended by Regulation (EC) No 2883/94 (4), lays down in particular the detailed rules for the application of the specific arrangements for the supply of certain agricultural products to the Canary Islands;

Whereas Commission Regulation (EC) No 2993/94 (5), as last amended by Regulation (EC) No 248/95 (6), fixed the amount of aid for milk products;

Whereas Commission Regulation (EC) No 288/95 of 13 February 1995 altering the export refunds on milk and milk products (7), adjusts the refunds on certain milk products; whereas the aid for certain products listed in the Annex to Regulation (EC) No 2993/94 should be adapted to take account of those adjustments,

HAS ADOPTED THIS REGULATION:

## Article 1

The Annex to amended Regulation (EC) No 2993/94 is hereby replaced by the Annex hereto.

## Article 2

This Regulation shall enter into force on 14 February 1995.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

- (\*) The aid on 100 kilograms of product falling within this subheading is equal to the sum of the following elements:
  - (a) the amount per 100 kilograms shown; however, where whey and/or lactose and/or casein and/or caseinates have been added to the products, the amount per 100 kilograms shown shall be:
