COMMISSION REGULATION (EC) No 1927/95

of 3 August 1995

amending the import duties in the cereals sector

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 1766/92 of 30 June 1992 on the common organization of the market in cereals (1), as last amended by Regulation (EC) No 1528/95 (2),

Having regard to Commission Regulation (EC) No 1502/95 of 29 June 1995 laying down detailed rules for the application of Council Regulation (EEC) No 1766/92 for the 1995/96 marketing year as regards import duties in the cereals sector (3), and in particular Article 2 (1) thereof,

Wheres the import duties in the cereals sector are fixed by Regulation (EC) No 1913/95 (4);

Whereas Article 2 (1) of Regualtion (EC) No 1913/95 provides that if during the period of application, the average import duty calculated differs by ECU 5 per tonne from the duty fixed, a corresponding adjustment is to be made; whereas such a difference has arisen; whereas it is therefore necessary to adjust the import duties fixed in Regulation (EC) No 1913/95,

HAS ADOPTED THIS REGULATION:

Article 1

Annexes I and II to Regulation (EC) No 1913/95 are hereby replaced by Annexes I and II to this Regulation.

Article 2

This Regulation shall enter into force on 4 August 1995.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

⁽⁴⁾ The importer may benefit from a flat-rate reduction of ECU 8 per tonne, where the conditions laid down in Article 2 (5) of Regulation (EC) No 1502/95 are met.
