

**COMMISSION REGULATION (EC) No 1187/98**  
**of 8 June 1998**  
**fixing the minimum selling prices for beef put up for sale under the invitation to**  
**tender referred to in Regulation (EC) No 1029/98**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 805/68 of 27 June 1968 on the common organisation of the market in beef and veal<sup>(1)</sup>, as last amended by Regulation (EC) No 2634/97<sup>(2)</sup>, and in particular Article 7(3) thereof,

Whereas tenders have been invited for certain quantities of beef fixed by Commission Regulation (EC) No 1029/98<sup>(3)</sup>;

Whereas, pursuant to Article 9 of Commission Regulation (EEC) No 2173/79<sup>(4)</sup>, as last amended by Regulation (EC) No 2417/95<sup>(5)</sup>, the minimum selling prices for meat put up for sale by tender should be fixed, taking into account tenders submitted;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Beef and Veal,

HAS ADOPTED THIS REGULATION:

*Article 1*

The minimum selling prices for beef for the invitation to tender held in accordance with Regulation (EC) No 1029/98 for which the time limit for the submission of tenders was 26 May 1998 are as set out in the Annex hereto.

*Article 2*

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
