COMMISSION REGULATION (EC) No 1956/2000

of 14 September 2000

amending the rates of the refunds applicable to certain products from the milk sector exported in the form of goods not covered by Annex I to the Treaty

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EC) No 1255/1999 of 17 May 1999 on the common organisation of the markets in the milk and milk products sector (1), as last amended by Regulation (EC) No 1670/2000 (2), and in particular Article 31(3) thereof,

Whereas:

(1) The rates of the refunds applicable from 1 September 2000 to the products listed in the Annex, exported in the form of goods not covered by Annex I to the Treaty, were fixed by Commission Regulation (EC) No 1865 2000 (3), as amended by Regulation (EC) No 1871/ 2000 (4).

It follows from applying the rules and criteria contained in Regulation (EC) No 1865/2000 to the information at present available to the Commission that the export refunds at present applicable should be altered as shown in the Annex hereto,

HAS ADOPTED THIS REGULATION:

Article 1

The rates of refund fixed by Regulation (EC) No 1865/2000 are hereby altered as shown in the Annex hereto.

Article 2

This Regulation shall enter into force on 15 September 2000.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
