COUNCIL DECISION

of 30 March 2009

appointing members and alternate members of the Advisory Committee on Social Security for Migrant Workers

(2009/C 83/07)

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 1408/71 of 14 June 1971 on the application of social security schemes to employed persons, to self-employed persons and to members of their families moving within the Community ⁽¹⁾, and in particular Article 82 thereof,

Having regard to the lists of candidates submitted to the Council by the Governments of the Member States,

Whereas:

- (1) By its Decision of 22 March 2007 ⁽²⁾, the Council appointed the members and alternate members of the Advisory Committee on Social Security for Migrant Workers for the period 22 March 2007 to 21 March 2009.
