Having regard to the Treaty establishing the European
Community, and in particular Article 168a thereof,

Having regard to the Treaty establishing the European
Coal and Steel Community, and in particular Article 32d
thereof,

Having regard to the Treaty establishing the European
Atomic Energy Community, and in particular Article
140a thereof,

Having regard to Council Decision 88/591/ECSC, EEC,
Euratom of 24 October 1988 establishing a Court of First
Instance of the European Communities ⁽¹⁾,

Whereas the terms of office of Mr Josef Azizi, Mr Corne-
lius Paulus Briet, Mr Marc Jaeger, Mr Andreas Kalogero-
poulos, Mr Koenraad Lenaerts, Mr Rui Manuel Gens de
Moura Ramos, Mrs Virpi Tiili and Mr Bo Vesterdorf
expire on 31 August 1998;

Whereas the partial replacement of members of the Court
of First Instance should take place for the period from 1
September 1998 to 31 August 2004;

Whereas, to complete the partial replacement of members
of the Court of First Instance, it will be necessary to
appoint a judge at a later date,

HAVE DECIDED AS FOLLOWS:
