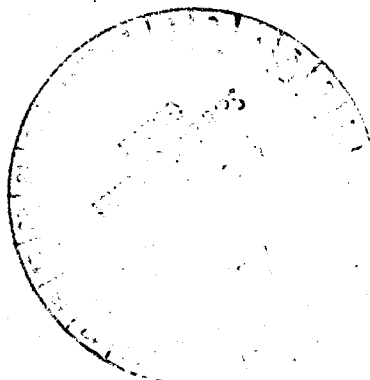

Amendment to the proposal for a
COUNCIL REGULATION

on temporary importation arrangements

(submitted to the Council by the Commission
pursuant to Article 149 (2) of the EEC Treaty)

EXPLANATION

Following the opinion given by the European Parliament on the proposal for a Council Regulation on temporary importation arrangements, the Commission wishes to make use of the possibility offered by Article 149 (2) of the Treaty establishing the European Economic Community to amend its original proposal by associating itself with the European Parliament's wish to include in the proposal sufficient means to ensure a uniform implementation of temporary importation arrangements. The corollary of this amendment is to generalize the provision for delegation.

Amendment
to the
proposal for a Council Regulation
on temporary importation arrangements

(Amendment pursuant to Article 149 (2) of the EEC Treaty)

The Commission hereby amends its proposal as follows :

New wording of Article 34:

The provisions necessary for the implementation of this Regulation, and in particular of Articles 5(2) and 32(1) thereof, shall be adopted in accordance with the procedure laid down by Article 28 of Directive 69/73/EEC.
