

PROPOSAL FOR A COUNCIL REGULATION (EEC)
CONCERNING, FOR CERTAIN FISH STOCKS OCCURRING IN THE COMMUNITY
FISHING ZONE, THE FIXING OF THE TOTAL ALLOWABLE CATCHES FOR
1981 AND THE CONDITIONS FOR TAKING THESE CATCHES
TOGETHER WITH THE SHARES AVAILABLE TO THE COMMUNITY

EXPLANATORY MEMORANDUM

1. The object of this proposal is to fix, for fish stocks occurring in the Community fishing zone, the total allowable catches (TACs) for 1981, the share of these TACs available to the Community when account is taken of its commitments to interested non-member states, and certain conditions regarding by-catches etc., which must be observed in fishing the TACs.
2. This proposal is based on the management policy set out by the Commission in its communication to the Council of 21.11.1979 (COM(79) 687 final). The essence of the policy is to take measures to ensure the continuance of each fish stock as a commercially viable resource, to decrease fishing effort on over-exploited stocks in order to avoid widely fluctuating yields from year to year, and then to move the degree of exploitation of individual stocks towards the level giving the maximum average long-term catch. It was on the basis of these objectives that the Council at its meeting of 29 January, 1980 accepted the TACs proposed for 1980 by the Commission. The policy is, however, a long-term one and has not yet been implemented for a sufficiently long period to have shown obvious results. The levels of exploitation and TACs recommended for 1981 are therefore very similar to those for 1980 for the majority of stocks, the variations that do occur reflecting mainly short-term changes caused by fluctuations in year class strength.
3. In maintaining these proposals the Commission is motivated principally by the socio-economic needs of the fishing industry. The real interests of Community fishermen demand that fishing patterns should be stabilised as quickly as possible and that catch yields and, therefore, profitability should be increased in the face of the rising costs of fishing. The only way to do this is to reduce the fishing mortality rate. In this respect, the Commission wishes to emphasize that it is precisely because it is aware of the socio-economic needs of the fishing industry that it has adopted a gradualist approach in making its TAC proposals because to bring the fishing effort down to the desired level in one step would mean that the majority of TACs would be unacceptably small.
4. Consultations with certain third countries about the determination of reciprocal fishing arrangements for 1980 are now in progress or about to start. The uncertainty resulting from the lack of agreement at present with

these partners may affect the present proposals and especially the eventual amounts available for the Community in respect of certain stocks such as those in the North Sea, Baltic and NAFO 1-zone. When these consultations are completed the Commission will adjust its proposal accordingly .

With these exceptions, however, the Commission considers that the evaluation of the overall position which this proposal provides has the comprehensive character which, if the Council adopts the proposal, should allow Community fishermen, without delay, to plan the development of their operations throughout this year's fishing season.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, [and

whereas in order to ensure the protection of the fishing grounds and stocks
of fish and to ensure thereby a balanced exploitation of the resources of the
sea in the interests of both fishermen and consumers, there should be fixed
each year for each species requiring a limitation of catches, a total allowable
catch (TAC) per stock or group of stocks, the share of the TACs available for
the Community, taking into account commitments to third countries and the condi-
tions governing the carrying out of fishing operations :

Article 1

The total allowable catches (TACs) fixed for 1981, on the basis of stocks or groups of stocks, in the waters under the sovereignty or jurisdiction of the Member States and subject to Community fishing regulations, together with the shares of these TACs available for the Community and the conditions governing the taking of these potential catches, are set out in the annex hereto.

Article 2

The Council, acting by a qualified majority on a proposal from the Commission, may modify the annex of this Regulation in order, if necessary, to take account of new scientific advice becoming available, changes in any other of the factors on which the provisions of this Regulation are based and any subsequent modifications in the agreements reached with interested non-member States about the allocation to them of quotas for fishing in the Community fishing zone in 1981.⁷*

Article 3

This Regulation shall enter into force on the 3rd day after publication in the Official Journal of the European Communities.

It is applicable from 1.1.1981.

This Regulation shall be binding in its entirety and shall be directly applicable in all Member States.

(1) To protect the 'eastern' stock, fishing for mackerel is forbidden in ICES division VIa) north of latitude 56°00'N from 1 March 1981 to 30 April 1981.

- (1) Subject to the introduction of a zone in which fishing for this stock would be prohibited, or of any other appropriate measure taking into account the experience acquired from applying by-catch provisions.
- (2) 7.500 tonnes exclusively reserved to coastal fishermen of Greenland.
- (3) Special allocation exclusively reserved for coastal fishermen of Greenland, by-catch not included. By-catches of halibut from this zone shall not exceed 3% by weight of catches of other species for which a TAC has been fixed. The detailed rules of implementation to ensure compliance with the rates of by-catches will be adopted by the Council before 31.12.1980.
