MEGOTIATIONS FOR THE ACCESSION OF PORTUGAL

Twenty-second report on the examination of Community secondary legislation

Supplement to the previous reports concerning acts relating to the following fields:

EXTERNAL RELATIONS (EEC and ECSC) STATISTICS

(Commission Communication to the Council)

1. In continuation of the systematic examination of Community secondary legislation undertaken with the Portuguese Delegation in accordance with the brief received from the Council, the Commission has carried out an interim supplementary examination of the acts adopted by the institutions of the European Communities in the following fields: external relations (EEC and ECSC acts), statistics.

This supplementary examination covered the general acts adopted and/or published after the closing dates for the previous examinations of Community legislation and in force on 1 March 1982.

In the field of external relations, however, it seemed advisable, as in previous examinations, to exclude from the scope of the supplementary examination the acts concerning relations between the Community and Portugal as these acts, by definition, will lapse in the event of the accession of that State.

In addition, Council Regulations (EEC) No 3601/81, No 3602/81 and No 3603/81 of 7 December 1981 and Decision 81/1011/ECSC of the representatives of the Governments of the Nember States of the ECSC of 7 December 1981 (OJ No L 365 of 21 December 1981), concerning the application of generalized tariff preferences for 1982 to products (industrial, textile, agricultural and iron and steel products respectively) originating in the developing countries, were also excluded from the examination as they are applicable only to 1982. Any acts adopted with a view to the multiannual application of the generalized preferences for subsequent years will be examined at a later stage of the work relating to customs legislation.

Furthermore, as in the initial examination of the acts relating to statistics, this supplementary examination did not deal with acts concerning specific surveys or statistics in the fields of transport, social affairs and agriculture, as these have been or will be examinated together with all the Community acts relating to those fields.

2. The results of the supplementary examination are set out in the two annexes to this report.

Annex I lists the new acts examined which do not require any technical adaptation to take account of Portugal's accession.

Annex II gives details of the technical adaptations which need to be made to certain acts and which will have to be specified in the accession instruments.

3. In the course of this interim supplementary examination it was found that certain acts which were in force at the time of the previous examinations of each of the fields in question — and which were accordingly included in the examinations — have since lapsed or have been amended by new acts adopted subsequently.

Any amendments which consequently need to be made to the technical adaptations set out in the conclusions of the reports embodying the results of the previous examinations are given in Annex II to this report in the form of corrections or additions to be made to the said previous conclusions.

4. Examination of the new acts adopted in the fields in question did not reveal any special problems which would have to be resolved in the framework of the substantive negotiations.

- 4. Points 5 (concerning Regulation (EEC) No 3061/79), 6 (concerning Regulation (EEC) No 3286/80) and 7 (concerning Decision 80/605/EEC) should be renumbered 4, 5 and 7.
- 5. In point 6, to be renumbered as 5 (and concerning Regulation (EEC) No 3286/80), the following should be added to the list of acts amending the regulation in question:
