EXPLANATORY MEMORANDUM

In Protocol No. 3 to the EEC-Yugoslavia agreement certain amounts in value are fixed to determine when EUR.2 forms should be used in place of EUR.1 certificates and when no proof of origin is required. These amounts are at present still expressed in European Units of Account (EUA).

Given that since 1 January 1981, the ECU has replaced the EUA in all sectors in the Community where this unit of account previously applied, it is now necessary to make certain editorial amendments to those Articles of Protocol No. 3 to the cooperation agreement containing the term EUA.

This replacement is merely a change to the text rather than a change of substance as the amounts set out in Articles 6 and 17 of Protocol No. 3 were revised by an autonomous Community act.

This amendment shall take the form of a decision of the forthcoming EEC-Yugoslavia Cooperation Council.

For reasons of simplification, the proposal for a Council Regulation applying the Cooperation Council Decision when adopted, is annexed.

substituting the ECU for the European unit of account in Protocol No. 3 concerning the definition of the concept of originating products and methods of administrative cooperation, annexed to the Cooperation Agreement between the European Economic Community and the Socialist Federal Republic of Yugoslavia

THE COOPERATION COUNCIL,

Having regard to the Cooperation Agreement between the European Economic Community and the Socialist Federal Republic of Yugoslavia signed in Belgrade on 2 April 1980, and hereinafter referred to as the "Agreement",

Having regard to Protocol No. 3 to the Agreement concerning the definition of the concept of originating products and methods of administrative cooperation, and in particular Article 25 thereof,

Whereas in Protocol No. 3 to the Agreement the European unit of account is used as a common unit of value for determining when EUR.2 forms may be used instead of EUR.1 movement certificates and when there is no need to produce proof of origin;

Whereas with effect from 1 January 1981 the Community began using the ECU in place of the European unit of account;

Whereas in consequence "ECU" should be substituted for the expression "European unit of account" in Protocol No. 3;

HAS DECIDED AS FOLLOWS :

Article 1

All references to "European unit of account" in Article 6(1) and Article 17(2) of Protocol No. 3 shall be replaced by "ECU".

on the 2 April 1980 and entered into force on 1 April 1983 ;

Whereas pursuant to Article 25 of Protocol No. 3 concerning the definition of
the concept of originating products and methods of administrative cooperation,
which forms an integral part of the said Agreement, the Cooperation Council
adopted Decision No. replacing all references to "European unit of account"
in Article 6(1) and Article 17(2) of the said Protocol by "ECU";

Whereas this Decision must be implemented in the Community,

HAS ADOPTED THIS REGULATION :

Article 1

Decision No. of the EEC-Yugoslavia Joint Committee shall apply in the
Community.

EXPLANATORY MEMORANDUM

Annex I to Protocol No. 3 contains "explanatory notes" in respect of certain Articles of this Protocol, including note 6 which explains inter alia the basis on which customs value referred to in Article 4 should be defined.

In view of the fact that the Community and Yugoslavia now apply the agreement regarding the application of Article VII of the General Agreement on Trade and Tariffs (GATT) which sets up a new system for determining customs value, Note 6 of Annex I to Protocol No. 3 should accordingly be amended to take account of the new situation.

This amendment shall be made by a EEC-Yugoslavia Cooperation Council Decision.

For reasons of simplification, the proposal for a Council Regulation applying the Cooperation Council Decision when adopted, is annexed.

THE COOPERATION COUNCIL,

Having regard to the Cooperation Agreement between the European Economic Community and the Socialist Federal Republic of Yugoslavia signed in Belgrade on 2 April 1980 and hereinafter referred to as the "Agreement",

Having regard to Protocol No. 3 to the Agreement concerning the definition of the concept of originating products and methods of administrative cooperation, and in particular Article 25 thereof,

Whereas Note 6 of Annex I to Protocol No. 3 explains the basis on which customs value referred to in Article 4 of the said Protocol must be defined;

Whereas the Community and Yugoslavia have accepted the agreement regarding the application of Article VII of the General Agreement on Tariffs and Trade (GATT), which entered into force on 1 January 1981; whereas this agreement introduces a new system for determining customs value;

Whereas Note 6 of Annex I to Protocol No. 3 should accordingly be amended to take account of this new situation,

HAS DECIDED AS FOLLOWS :

Article 1

The second paragraph of Note 6 re. Article 4 set out in Annex I to Protocol No. 3 shall be replaced by the following :

" "Customs value" shall be understood as meaning the customs value laid down within the framework of the agreement concerning the application of Article VII of the General Agreement on Tariffs and Trade which entered into force on 1 January 1981. "
