EXPLANATORY MEMORANDUM

1. Regulation (EEC) No 1430/82 provides for some restrictions on the aid for hemp and on the importation of hemp and of sowing seed and others, in particular on restrictions on the importation of other hemp seed. These provisions aim to protect human health and they shall apply from 1 August 1983.
  
2. The deadline presents no difficulties for the first measures but it cannot be respected for the measures regarding hemp seed for other purposes than  
  
In fact, some technical problems with the setting up and application of these provisions especially concerning the maximum germination rate were indeed more difficult to solve than initially foreseen.  
Moreover, more time should be given to Member States' Administrations and operators to conform to the obligations resulting in applying Regulation (EEC) No 1430/82.  
For these reasons the deadline of 1 August 1983 cannot be respected.
  
3. Therefore the Commission proposes to defer the application of this regulation from 1.8.1983 until 1.8.1984 as agreed at the S.C.A. on 27/28 June 1983.

Proposal for a

COUNCIL REGULATION (EEC)

amending Regulation (EEC) No 1430/82 providing for restrictions on the importation of hemp and hemp seed and amending Regulation (EEC) n° 1308/70 in respect of hemp.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 42, 43 and 113 thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament (1),

Whereas the second indent of the second subparagraph of Article 3 of Council Regulation (EEC) n° 1430/82 (2) as amended by Regulation (EEC) n° 201/83 (3) provides that this Regulation shall apply from 1 August 1983; whereas, taking into account some inherent technical difficulties in applying some measures provided for in this regulation, this deadline cannot be respected; whereas it should be deferred to 1 August 1984.

Article 1

Article 3 of Regulation (EEC) no 1430/82 is replaced by the following :

" This Regulation shall enter into force on the third following its publication in the Official Journal of the European Communities.

It shall apply from 1 August 1984. "

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

It shall apply from 1 August 1983.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
