Subject : Request for assent, pursuant to Article 56 2a) of the ECSC Treaty to the granting of a global loan to The Royal Bank of Scotland p.l.c., United Kingdom.

I. FINANCIAL INTERMEDIARY

II. RECIPIENTS
=====

: The Royal Bank of Scotland p.l.c. will, through its local branch network, on-lend the global amount in the form of sub-loans to small and medium sized firms for the expansion of existing and/or the creation of new activities.

Field of Activity of recipients

: Industrial and service sectors.

III. THE PROJECT
=====

Procedure

: This loan is in addition to a previous global facility for UK£ 5 million which has been fully utilised. In this instance the Commission has decided to make UK£ 10 million (about 17.025 MioECU) available to the Royal Bank of Scotland to be disbursed in sub-loans to small and medium sized businesses in ECSC employment areas. The loan will be paid in instalments as sub-loans are approved. The Commission will approve sub-loans on the basis of its published operating principles (O.J. No. C 191 of 16 July, 1983). The bank will report annually to the Commission on the use made of the global loan, on the total number of jobs created and actually occupied, and on the re-employment of ex-ECSC workers by the sub-borrowers. The Royal Bank of Scotland p.l.c. and Williams and Glyn's Bank p.l.c. will merge on 1 October, 1985 under the title of the former, thus considerably expanding the availability of this global loan facility.

: at least UK£ 20,000,000 (+ 34.051 MioECU)

VI. GLOBAL LOAN

Loan applied for

: UK£ 10,000,000

Loan to be granted

: The Commission has approved a loan of UK£ 10,000,000 (about 17.025 MioECU) or equivalent to the above mentioned institution (1)

Interest rebate

: 5 percentage points per year for five years on 17.02 MioECU

Job basis of interest rebate

: 851 jobs (i.e. two thirds of the jobs to be created)
