EXPLANATORY MEMORANDUM

On 26 July 1989 the Commission presented to the Council a proposal for a Directive amending Directive 69/169/EEC to increase in real terms the tax-paid allowances in intra-Community travel.¹

The Economic and Social Committee delivered a favourable opinion on this proposal on 18 October 1989;² Parliament, while approving the principle of the proposal, included in its opinion of 22 November 1989³ two amendments whose purpose is to indicate clearly that the import restrictions provided for in the Directive will be progressively dismantled, until they are completely lifted on 1 January 1993.

The Commission has accepted these amendments.

abolished.
