EXPLANATORY MEMORANDUM

1. Subsequent to requests made by various Member States, the Services of the Commission have examined, in conjunction with the Government experts concerned, the question of opening in 1996 tariff quotas for various products.
2. Following this examination, which took place during the "Economic Tariff Questions" group meetings, it has been determined that the opening and increase of tariff quotas for industrial and fishery products could have the agreement of the Member States without disturbing the markets for such products,

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European
Community, and in particular Article 28 thereof,

Having regard to the proposal from the Commission,

Whereas production in the community of certain industrial and
fishery products will remain in the course of 1996 unable to
meet the specific requirements of the user industries in the
Community; whereas, consequently, Community supplies of
products of this type will depend to a considerable extent on
imports from third countries; whereas the most urgent
Community requirements for the products in question should
be met immediately on the most favourable terms;

Whereas by Regulation (EC) n° 3059/95¹ the Council opened,
for 1996 Community tariff quotas for certain agricultural and
industrial products; whereas the volume of the quota for glass
granulate (Order Nr. 09.2867), and felt tips (order Nr.
09.2894) should be increased and new tariff quotas should be
opened within the limits of appropriate volumes taking into
account of the need not to disturb the markets for such
products nor the starting out or development of Community
production;

HAS ADOPTED THIS REGULATION:

Article 1

In the Regulation (EC) n° 3059/95 the table shown in the
Annex is replaced, for the order n° 09.2867 and 09.2894 by
the table shown in the Annex of this Regulation. In addition,
the order numbers 09.2701, 09.2791, 09.2933,
09.2934, 09.2935 listed in the Annex of this Regulation are
added to the table in the Annex of Regulation (EC) n°
3059/95.

Article 2

This Regulation shall enter into force on the 3rd day following
its publication in the Official Journal of the European
Communities.

This Regulation shall be binding in its entirety and directly
applicable in all Member States.
