# 21. Côte d'Ivoire

#### B5-0906, 0912, 0919, 0927 and 0934/2000

### European Parliament resolution on Côte d'Ivoire

The European Parliament,

- having regard to its previous resolutions on Côte d'Ivoire,
- having regard to the terms of the consultations on the EU-ACP Convention in the first half of 2000,
- A. deeply concerned at the resumption of violence in Côte d'Ivoire in the run-up to the legislative elections of 10 December 2000, which caused several deaths in clashes between security forces and supporters of the opposition Rally of the Republicans,
- B. whereas the legislative elections were held on 10 December without the participation of the voters in the Northern regions and without international observers, from either the UN, the OAU or the European Union,
- C. whereas turnout was low across the country and polling was abandoned in 32 constituencies in the Muslim north of the country,
- D. having regard to the decision of the National Electoral Commission to declare Mr Ouattara eligible,
- E. regretting the decision of the Côte d'Ivoire Supreme Court which on grounds of 'doubtful nationality' rejected the candidature of Mr Alassane Ouattara, leader of the Rally of the Republicans,
- F. whereas over 30% of the 15 million population have their origins in the north of the country, and ignoring this fact would mean excluding a section of the population from the electoral process,
- G. having regard to the proposal by the Mediation Committee for National Reconciliation to put back the date of the elections to allow time for a legal solution to the crisis,
- H. deeply concerned at the exacerbation of the debate on Ivorian identity and its exploitation by certain political forces and parts of the Côte d'Ivoire media which is threatening political stability and national unity,
- 1. Deplores the decision of the Côte d'Ivoire Supreme Court, which was installed by the military junta, to bar Mr Ouattara from standing in the legislative elections, thus excluding part of the population from the electoral process;
- 2. Regrets the fact that the elected President did not question the authority of this body which was appointed in its entirety by a general involved in the coup;
- 3. Deplores the exclusion of Mr. Ouattara from the legislative elections and as a result considers that these elections lack democratic legitimacy;
- 4. Strongly condemns the recent violence and killings in the run-up to the 10 December legislative elections and calls for a thorough and independent investigation so that those responsible may be brought to justice;
- 5. Calls for the immediate release of the leaders of the RDR;
- 6. Expresses its alarm at, and its condemnation of, the explosion of xenophobia triggered by the debate on Ivorian identity and all use of force to settle political differences;

- 7. Calls on the leaders now in power to seek a political and democratic solution to the current crisis by taking into account the overall balance of political forces in the country;
- 8. Urges the Ivorian authorities to organise new elections as soon as possible, without exclusion of candidates on ethnic grounds, in order to restore the democratic legitimacy of the institutions and a climate of national cohesion, reconciliation and peace, in which all communities have their place;
- 9. Believes that human, political and civil rights and the right to political pluralism are fundamental rights allowing voters to have a real choice of candidates;
- 10. Calls on the Council and Commission immediately to review EU cooperation with Côte d'Ivoire and at all events to open immediate consultations with its Government, according to the procedure pursuant to Article 96 of the Cotonou Partnership Agreement, in order to jointly agree a timetable for the return to democracy;
- 11. Calls on the Commission to continue the EU assistance directly provided by NGOs to the most vulnerable sectors of the population;
- 12. Instructs its President to forward this resolution to the Council, the Commission, the Côte d'Ivoire Government, the Secretary-General of the OAU and the Co-Presidents of the ACP-EU Joint Assembly.
