Judgment of the General Court (Sixth Chamber) of 28 February 2012 — Grazer Wechselseitige Versicherung v Commission

(Case T-282/08)

(State aid — Aid granted by the Austrian authorities to the Grazer Wechselseitige group (GRAWE) in connection with the privatisation of Bank Burgenland — Decision declaring the aid to be incompatible with the common market and ordering its recovery — Private investor in a market economy test — Application where the State acts as vendor — Determination of the market price)

- 5. State aid Concept Assessment according to the criterion of the private investor Transfer of an undertaking Uncertain outcome and duration of an authorisation procedure not automatically implying the exclusion of a buyer by a private investor (Art. 87(1) EC) (see paras 88, 90, 100, 101)
- 6. State aid Concept Assessment according to the criterion of the private investor Whether account to be taken, in determining the transfer price of an undertaking, of the risk represented by the existence of a statutory guarantee scheme benefiting the undertaking to be transferred Not included (Art. 87(1) EC) (see paras 122, 128, 130, 131)
