

- with regard to the unlawfulness of the President's letter of 27 July 2011:
  - material damage due to loss of earnings: EUR 113 100;
  - non-material damage: EUR 50 000
- with regard to the psychological harassment she suffered:
  - material damage in respect of earnings and loss of career: EUR 132 100;
  - non-material damage: EUR 50 000;
  - associated costs: EUR 13 361,93;
- with regard to maladministration on the part of the EIB:
  - breach by the EIB of its obligation of confidentiality and data protection: EUR 10 000;
  - incident regarding the examination of witnesses: EUR 40 000;
- order the EIB to pay the costs.
