# Action brought on 11th July 2013 — ZZ v Commission

# Subject-matter and description of the proceedings

The annulment of the decision refusing the recruitment of the Applicant considering that he does not fulfill the eligibility criteria set in the EPSO/AD/207/11 competition notice.

# Form of order sought

- Annul the decision of the Unit B.2 in Directorate General Human Resources and Security of the European Commission dated 26 September 2012 which refused his recruitment at the Commission (ESTAT) from the reserve list of competition EPSO/AD/207/11 and adding a comment in the reserve list of that competition informing the Commission's departments that the applicant did not meet the conditions of eligibility for that competition;
- if necessary, annul the decision of the Director of DG HR.D.2 of the European Commission rejecting the complaint lodged by ZZ (No. Rl696/12) dated 25 February 2013;
- order the Commission to pay the costs.

# Action brought on 9 August 2013 — ZZ v Commission

# Subject-matter and description of the proceedings

Application for annulment of the decision considering the applicant ineligible for the call for expressions of interest CAST/02/2010 and rejecting the PMO's request for a member of the contract staff to be recruited.

#### Form of order sought

- annulment of the decision of the AECE of 8 November 2012 considering the applicant ineligible for the call for expressions of interest CAST2010 and refusing to offer him a contract for an indefinite period as a member of the contract staff for function group III (FGIII);
- order the Commission to pay the costs.

# Action brought on 23 August 2013 — ZZ v EEAS

#### **Parties**

Applicant: ZZ (represented by: J.-N. Louis, A. Coolen and É. Marchal, lawyers)

Defendant: European External Action Service (EEAS)

# Subject-matter and description of the proceedings

Application for annulment of the decision to transfer the applicant from the EEAS office in Burundi to its headquarters in Brussels.

# Form of order sought

- annul the decision of 15 July 2013 of the High Representative of the European Union to transfer the applicant, in the interests of the service, with immediate effect to a position in the MDR.C in Brussels;
- declare that the EEAS committed a series of breaches of its administrative duties by adopting the contested decision, breaches which render the European Union liable;
- declare that the contested decision causes the applicant and his spouse serious damage;
- take formal notice of the action;
- order the EEAS to pay the costs.
