**Order of the Civil Service Tribunal (First Chamber) of 25 March 2015 — Singou v Council
(Case F-143/14)**

***(Civil Service — Contract staff — Rejection of a complaint of psychological harassment — Non-renewal
of contract — No claim — Manifestly inadmissible)***

Defendant: Council of the European Union

Re:

Application for annulment of the decision of the Appointing Authority of 5 March 2009 to reject a complaint of psychological harassment made by the applicant and application to annul the decision of the Appointing Authority of 12 April 2012 by which the Appointing Authority refused to extend the applicant's contract or transform it into a permanent contractual staff contract, and applications for damages for the material and non-material harm allegedly suffered.

Operative part of the order

1. *The action is dismissed as manifestly inadmissible.*
 2. *The application for legal aid is rejected.*
 3. *Mr Singou shall bear his own costs.*
