Order of the President of the General Court of 20 October 2022 – PB v Commission

(Case T-407/21 R)

(Interim relief — Public service contracts — Irregularities in the contract award procedure — Recovery of amounts unduly paid — Enforceable decision — Application for interim measures — Urgency — Prima facie case — Balance of interests)

1. Interim relief – Suspension of operation of a measure – Interim measures – Conditions for granting – Prima facie case – Urgency – Serious and irreparable damage – Cumulative nature – Balancing of all the interests involved – Order of examination and method of verification – Discretion of the court hearing the application for interim relief

Interim relief – Suspension of operation of a measure – Conditions for granting – Prima facie case – Prima facie examination of the pleas in law put forward in support of the main action – Actions brought against enforceable decisions adopted by the Commission for the recovery of amounts unduly paid under public contracts – Plea alleging that the Commission did not have jurisdiction to adopt those decisions in the absence of an arbitration clause – Plea not prima facie lacking in foundation
