## Judgment of the General Court (First Chamber) of 20 September 2023 – Mordashov v Council

(Case T-248/22)1

(Common foreign and security policy – Restrictive measures taken in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine – Freezing of funds – Inclusion and maintenance of the applicant's name on the lists of persons, entities and bodies concerned – Article 2(1)(a), (d), (f) and (g) of Decision 2014/145/CFSP – Right to effective legal protection – Obligation to state reasons – Error of assessment – Proportionality – Equal treatment – Right to property)

Acts of the institutions – Statement of reasons – Obligation – Scope – Restrictive measures taken in view of the situation in Ukraine – Freezing of the funds of leading businesspersons involved in economic sectors providing a substantial source of revenue to the Government of the Russian Federation and persons associated with them – Obligation to identify in the statement of reasons the specific and concrete elements justifying the said measure – Decision falling within a context known to the person concerned, enabling him or her to understand the scope of the measure taken against him or her – Whether summary statement of reasons sufficient
