## Prior notification of a concentration (Case No IV/M.518 — Winterthur/Schweizer Rück)

(95/C 44/03)

## (Text with EEA relevance)

- 1. On 13 February 1995, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EEC) No 4064/89 (1) by which 'Winterthur' Schweizerische Versicherungs-Gesellschaft acquires within the meaning of Article 3 (1) (b) of the Council Regulation control of Schweiz Assicurazione SpA, Schweiz Vita SpA, Schweiz Compañia Anónima Española de Seguros y Reaseguros and La Equitativa, SA by way of purchase of shares from Schweizerische Rückversicherungs-Gesellschaft.
- 2. The business sector concerned is insurance, mainly in Italy, Spain and Portugal.
- 3. Upon preliminary examination, the Commission finds that the notified concentration could fall within the scope of Regulation (EEC) No 4064/89. However, the final decision on this point is reserved.
- 4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.
