- 13. Companies or ad hoc groupings will not be admitted.
- 14. To be able to qualify interested companies must provide the following information in their tender:

  - share capital on the date of publication of this notice.

Tenderers must also provide the following documents (only original documents or authenticated copies will be accepted):

- the company's statutes;

- certificate of enrolment at the court of justice and/or at the relevant Chamber of Commerce;
- certificate issued by the competent authority stating that the supplier has fulfilled obligations relating to the payment of social security contributions in accordance with the legal provisions of the country of origin;
- statement issued by the competent authority stating that the supplier has fulfilled obligations

relating to the payment of taxes in accordance with the legal provisions of the country of origin;

- family status, certificate of residence and a copy of the police record of all representatives and/or administrators.

They must state, on company-headed paper, that they are not in a state of bankruptcy, liquidation, suspension of business activities or legal settlement or any other similar situation in accordance with the legal provisions of the country of origin and that no proceedings which could lead to 1 of these situations are being brought against them.

15. Period during which the tender will be kept open:
6 months from the deadline for the dispatch of tenders indicated in 9 (a).

#### 16. Contract award criteria:

- companies must explicitly guarantee that they are capable of providing the Commission, 24 hours a day at the I-Ispra site or in the immediate vicinity, with a sufficient number of vehicles with driver, having a cubic capacity of not less than 1 950 cc and the whole fleet being of a dark uniform colour, and with minibuses with driver, having a capacity of 9 persons, including driver, the whole fleet being of a light uniform colour;
- all vehicles used must be equipped with air conditioning;
- all vehicles must have a statutory hire/refund licence and must not carry any company logo or advertising;

- companies must provide evidence that they possess all the permits required for the vehicles in use;
- the number of vehicles required by the Commission, at present, is estimated at 10 cars and 3 minibuses;
- economic aspect of the tender;
- standard and quality of the service provided (condition of the vehicle fleet used: model, make, equipment, age, number of passenger vehicles available other than those made available to the Commission; company staff, apart from those normally employed, made available to the Commission. Smartness of the staff and presentation of the vehicles: uniforms, cleanliness of the vehicles, condition of upholstery and bodywork).
