**Action brought on 22 October 1999 by Total Nederland B.V. and Fina Nederland B.V. against the Commission of the European Communities**

**(Case T-252/99)**

*(Language of the case: Dutch)*

An action against the Commission of the European Communities was brought before the Court of First Instance of the European Communities on 22 October 1999 by Total Nederland B.V. and Fina Nederland B.V., respectively established in Rotterdam and The Hague (Netherlands), represented by E.H. Pijnacker Hordijk and R. Wesseling, of the Hague Bar, with an address for service in Luxembourg at the Chambers of M. Maître, 11 Rue Goethe.

The applicants claim that the Court should:

- (a) order the Commission of the European Communities to give the applicant's advisers access to its file relating to its decision of 20 July 1999 (C(1999) 2539 final)<sup>(1)</sup> concerning State aid granted by the Netherlands to 633 service stations in the region bordering Germany, and order the adoption of all such further measures as may be necessary;
- (b) annul Articles 2 and 3 of the Commission's decision of 20 July 1999 (C(1999) 2539 final);
- (c) order the Commission to pay the costs.
