

Open call for proposals for RT actions under the specific programme for research and training (Euratom) in the field of nuclear energy (1998 to 2002)

Call identifier: NE Open 2

(2001/C 290/08)

1. In accordance with the Decision of the Council of 22 December 1998, concerning the fifth framework programme of the European Atomic Energy Community (Euratom) for research and training (RT) activities for the period 1998 to 2002 ⁽¹⁾ (hereinafter referred to as the fifth framework programme), and with the Council Decision of 25 January 1999, adopting a research and training programme (Euratom) in the field of nuclear energy (1998-2002) ⁽²⁾ (hereinafter referred to as the specific programme), the European Commission hereby invites proposals for indirect RT actions under the specific programme.

In conformity with Article 5 of the specific programme, a work programme ⁽³⁾, specifying detailed objectives and RT priorities and an indicative timetable for their implementation, was drawn up in March 1999, subsequently revised on 25 July 2000 and 10 August 2001 by the European Commission to serve as the basis for implementing the specific programme. The objectives, priorities, indicative budget and types of indirect RT actions referred to in this call notice correspond to those set out in the work programme as revised on 10 August 2001.

2. This call relates to proposals, specified under point 4 of this call, called under a continuous submission scheme, under which, depending on the type of indirect RT actions submitted, proposals will be evaluated at fixed intervals (for which deadlines for receipt are provided).

Details of the types of indirect action, and, where applicable, their associated deadlines for receipt, are specified under point 4 of this call notice. Proposals under this scheme may be submitted at any time up to the date of closure of the scheme.

3. The specific programme is implemented notably through indirect RT actions as provided for in Annexes II and III of the fifth framework programme and in Annex III of the specific programme.

Evaluation and selection criteria and modalities relevant to this call are given in the fifth framework programme, the specific programme, the Council Decision of 22 December 1998, concerning the rules for the participation of under-

takings, research centres and universities in the implementation of the fifth framework programme of the European Atomic Energy Community (Euratom) ⁽⁴⁾ (hereinafter referred to as the rules for participation), and the work programme. The fifth framework programme manual of proposal evaluation procedures ⁽⁵⁾, along with its annex on this specific programme, provides further details.

Information on these rules and on how to prepare and submit proposals is given in the guide for proposers, which can be obtained, along with the work programme and other information relating to this call, from the European Commission using one of the following addresses:

5. Proposals must be **received** by the Commission before or on the deadline applicable to these type of indirect actions by one of the following methods:

When packaging a proposal for electronic submission, two files are created. The first is a small validation file, which provides basic information on the proposal and a unique identification code. This validation file must be received by the European Commission before or on the deadline specified above. The second file contains the proposal and must be received unmodified, as verifiable from the unique identification code, not later than 48 hours after this deadline.

Proposals submitted under the continuous submission scheme, which are not received before or on a given deadline for receipt, will be evaluated after the next deadline for receipt.

Further information is available in the guide for proposers.

Important: The above constitutes a change with respect to some earlier calls where the deadlines applied to submission. Deadlines now apply to receipt by the Commission.

Please note that failure to use the above address exactly as it is reproduced here could lead to delays in having your proposal received by this programme, and could correspondingly lead to your proposal not being received before the deadline.

Proposers are requested to use only one of the methods, described above, by which to submit proposals, and to submit only one version of any given proposal. In the case of an eligible proposal being received in both paper and electronic formats, only the electronic version will be evaluated.

The Commission will offer a pre-proposal check service for this call, as described in the guide for proposers. Proposals for this service will not be accepted later than six weeks before the cut-off dates indicated in the Annex.

6. In all correspondence relating to this call (e.g. when requesting information, or submitting a proposal) please make sure to cite the applicable call identifier.

In submitting a proposal, either on paper or electronically, proposers accept the procedures and conditions as described in this call and in the documents to which it refers.

All proposals received by the European Commission will be treated in strict confidence.

According to the rules for participation and the European Commission Regulation for implementing them, Member States and associated States may have access, on presentation of a reasoned request, to useful knowledge which is relevant to policy-making. This knowledge must have been generated by those RT actions supported as a result of this call and which addressed a part of the work programme specified as eligible for such access.

The European Atomic Energy Community pursues an equal opportunities policy and, in this context, women are particularly encouraged to either submit proposals or to participate in their submission.

7. This open call that comes into force at the date of the publication in the *Official Journal of the European Communities* cancels and replaces the open call 'NE-Open' (2000/C 294/05) published in the OJ C 294, 17.10.2000, p. 7.
