in Case C-472/00 P: Commission of the European Communities v Fresh Marine Company A/S ⁽¹⁾

(Appeal — Non-contractual liability of the Community — Provisional anti-dumping and countervailing duties imposed on imports of farmed Atlantic salmon originating in Norway)
