

- in the alternative, declare that, by failing to inform the Commission immediately of any such provisions, the Portuguese Republic has failed to fulfil its obligations under Article 24(1) of Directive 2000/60/EC;
- order the Portuguese Republic to pay the costs.

*Pleas in law and main arguments*

The period for transposing Directive 2000/60/EC into national law expired on 22 December 2003.
