## Prior notification of a concentration (Case COMP/M.4040 — KKR/FL Selenia) Candidate case for simplified procedure

## (Text with EEA relevance)

- 1. On 17 November 2005, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 (¹) by which the undertaking Sole Italy S.à.r.l. (Luxembourg), ultimately controlled by Kohlberg Kravis Roberts & Co. L.P. ('KKR', USA) acquires within the meaning of Article 3(1)(b) of the Council Regulation control of the whole of the undertaking FL Selenia S.p.A. ('FL Selenia', Italy) by way of purchase of shares.
- 2. The business activities of the undertakings concerned are:
- for undertaking KKR: private equity investments;
- for undertaking FL Selenia: manufacturing and distribution of automotive and industrial lubricants and functional fluids for automobiles and industrial vehicles.
- 3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of Regulation (EC) No 139/2004. However, the final decision on this point is reserved. Pursuant to the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004 (²) it should be noted that this case is a candidate for treatment under the procedure set out in the Notice.
- 4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.
