## (Text with EEA relevance)

- 1. On 9 March 2006, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 (¹) by which the undertakings The Coca-Cola Company (TCCC', USA) and Coca-Cola Hellenic Bottling Company S.A. ('CCHBC', Greece) acquire within the meaning of Article 3(1)(b) of the Council Regulation joint control of the undertaking Fonti del Vulture S.r.l.) ('Traficante', Italy) by purchase of shares.
- 2. The business activities of the undertakings concerned are:
- for TCCC: brand owner and supplier of soft drink concentrates;
- for CCHBC: licensed bottler that produces and sells TCCC-branded beverages;
- for Traficante: bottling and marketing mineral waters in principal in southern Italy.
- 3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of Regulation (EC) No 139/2004. However, the final decision on this point is reserved. Pursuant to the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004 (²) it should be noted that this case is a candidate for treatment under the procedure set out in the Notice.
- 4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.
