

**COMMISSION REGULATION (EC) No 2902/94**  
**of 29 November 1994**  
**altering the export refunds on white sugar and raw sugar exported in the natural state**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 1785/81 of 30 June 1981 on the common organization of the markets in the sugar sector<sup>(1)</sup>, as last amended by Regulation (EC) No 133/94<sup>(2)</sup>, and in particular the second subparagraph of Article 19 (4) thereof,

Whereas the refunds on white sugar and raw sugar exported in the natural state were fixed by Commission Regulation (EC) No 2800/94<sup>(3)</sup>, as last amended by Regulation (EC) No 2840/94<sup>(4)</sup>;

Whereas it follows from applying the detailed rules contained in Regulation (EC) No 2800/94 to the information known to the Commission that the export refunds at present in force should be altered to the amounts set out in the Annex hereto;

Whereas the representative market rates defined in Article 1 of Council Regulation (EEC) No 3813/92<sup>(5)</sup>, as amended by Regulation (EC) No 3528/93<sup>(6)</sup>, are used to convert amounts expressed in third country currencies

and are used as the basis for determining the agricultural conversion rates of the Member States' currencies; whereas detailed rules on the application and determination of these conversions were set by Commission Regulation (EEC) No 1068/93<sup>(7)</sup>, as amended by Regulation (EC) No 547/94<sup>(8)</sup>,

HAS ADOPTED THIS REGULATION :

*Article 1*

The export refunds on the products listed in Article 1 (1) (a) of Regulation (EEC) No 1785/81, undenatured and exported in the natural state, as fixed in the Annex to amended Regulation (EC) No 2800/94 are hereby altered to the amounts shown in the Annex hereto.

*Article 2*

This Regulation shall enter into force on 30 November 1994.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
