

CORRIGENDA**Corrigendum to Commission Directive (EU) 2015/1127 of 10 July 2015 amending Annex II to Directive 2008/98/EC of the European Parliament and of the Council on waste and repealing certain Directives**

On page 15, Annex, concerning the footnote (*) in Annex II to Directive 2008/98/EC, third subparagraph:

- for:* 'The value of HDD (Heating Degree Days) should be taken as the average of annual HDD values for the incineration facility location, calculated for a period of 20 consecutive years before the year for which CCF is calculated. For the calculation of the value of HDD the following method established by Eurostat should be applied: HDD is equal to $(18\text{ °C} - T_m) \times d$ if T_m is lower than or equal to 15 °C (heating threshold) and is nil if T_m is greater than 15 °C ; where T_m is the mean $(T_{\min} + T_{\max}/2)$ outdoor temperature over a period of d days. Calculations are to be executed on a daily basis ($d = 1$), added up to a year.'
- read:* 'The value of HDD (Heating Degree Days) should be taken as the average of annual HDD values for the incineration facility location, calculated for a period of 20 consecutive years before the year for which CCF is calculated.
