

COMMISSION DECISION
of 14 July 2017
on the members of the advisory group on the food chain and animal and plant health established
by Decision 2004/613/EC
(2017/C 230/05)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Decision 2004/613/EC of 6 August 2004 ⁽¹⁾ concerning the creation of an advisory group on the food chain and animal and plant health, and in particular Article 3 thereof,

Whereas:

- (1) An advisory group on the food chain and animal and plant health has been established by Decision 2004/613/EC with effect from 25 August 2004. This group is consulted by the Commission on its programme of work on food and feed safety, food and feed labelling and presentation, human nutrition in relation to food legislation, animal health and welfare, and plant health and also on any measures which the Commission has to take or propose in these fields.
- (2) Pursuant to Article 3(3) of Decision 2004/613/EC, the Commission shall select representative European bodies which most effectively meet the criteria referred to in Article 3(1) of that Decision and who have responded to the call for applications.
- (3) The Commission originally selected 36 members of the advisory group. The list of original members was published in the *Official Journal of the European Union* in 2005 ⁽²⁾.
- (4) The membership of the advisory group was extended by Decision 2011/242/EU ⁽³⁾.
- (5) The Commission has now revised the membership of the advisory group, in particular to take into account the requirements set up by the revised horizontal rules for Commission Expert Groups ⁽⁴⁾. Following a call for applications, 45 members have been selected.
- (6) All members of the advisory group have equal status,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission appoints as members of the advisory group on the food chain and animal and plant health the stakeholder bodies listed in the Annex.

Article 2

Appointment

Members shall be appointed for 5 years. Their term of office may be renewed.

Article 3

Repeal

Decision 2011/242/EU is repealed.
