European Parliament legislative resolution on the proposal for a Council decision on the conclusion, on behalf of the European Community and its Member States, of a Protocol to the Agreement on Cooperation and Customs Union between the European Economic Community and the Republic of San Marino, regarding the participation, as contracting parties, of the Czech Republic, the Republic of Estonia, the Republic of Cyprus, the Republic of Latvia, the Republic of Lithuania, the Republic of Hungary, the Republic of Malta, the Republic of Poland, the Republic of Slovenia and the Slovak Republic, pursuant to their accession to the European Union (COM(2004)0258 — C6-0048/2004 — 2004/0083(CNS))

 - having regard to Article 300(3), first subparagraph, of the EC Treaty, pursuant to which the Council consulted Parliament (C6-0048/2004),
 - having regard to Rules 51, 83(7) and 43(1) of its Rules of Procedure,
 - having regard to the report of the Committee on International Trade (A6-0062/2004),
1. Approves the conclusion of the protocol to the agreement;
 2. Instructs its President to forward its position to the Council, the Commission and the governments and parliaments of the Member States and the Republic of San Marino.
