2. *The report shall include a proposal on how, when vested pension rights are transferred, the undertaking's liability for such rights can be excluded.*

3. *No later than ... (*), the Commission shall draw up a report, in particular with regard to the conditions of transferring capital representing workers' supplementary pension rights. On the basis of that report, the Commission shall present any proposal containing amendments to this Directive or other instruments which prove necessary in order further to reduce the obstacles to the mobility of workers created by certain rules on supplementary pension provision.*

Article 10

Entry into force

This Directive shall enter into force on the 20th day following that of its publication in the *Official Journal of the European Union*.

This Directive is addressed to the Member States.

 - having regard to Rule 51 of its Rules of Procedure,
 - having regard to the report of the Committee on Economic and Monetary Affairs (A6-0244/2007),
1. Approves the Commission proposal;
 2. Favours the adoption of the euro by Cyprus on 1 January 2008;
 3. Calls on the Member States to allow the Commission to assess compliance with the Maastricht criteria on the basis of definite, current, reliable, and high-quality data;
 4. Calls on the Council to notify Parliament if it intends to depart from the text approved by Parliament;
 5. Asks the Council to consult Parliament again if it intends to amend the Commission proposal substantially;
 6. Instructs its President to forward its position to the Council, the Commission and the governments of the Member States.
