Notice concerning the anti-dumping and countervailing measures in force in respect of imports of certain pneumatic tyres, new or retreaded, of rubber, of a kind used for buses or lorries and with a load index exceeding 121 originating in the People's Republic of China: name change of one company subject to the duty for cooperating non sampled companies

Imports of certain pneumatic tyres, new or retreaded, of rubber, of a kind used for buses or lorries, with a load index exceeding 121 originating in the People's Republic of China, are subject to definitive anti-dumping and countervailing duties imposed by Commission Implementing Regulation (EU) 2018/1579 (1) (Regulation (EU) 2018/1579) and Commission Implementing Regulation (EU) 2018/1690 (2) (Regulation (EU) 2018/1690).

Sailun Jinyu Group Co. Ltd, TARIC (3) additional code C351, a company located in the People's Republic of China whose exports to the Union of certain pneumatic tyres, new or retreaded, of rubber, of a kind used for buses or lorries and with a load index exceeding 121, are subject to the anti-dumping duty amount of 21,62 EUR/item and of the countervailing duty amount of 27,69 EUR/item, informed the Commission that it had changed its name as set out below.

The company asked the Commission to confirm that the change of name does not affect the right of the company to benefit from the anti-dumping duty amount and countervailing duty amount applied to the company under its previous name.

The Commission examined the information supplied and concluded that the change of name in no way affects the findings of Regulation (EU) 2018/1579 and Regulation (EU) 2018/1690.

Therefore, the reference in the Annex of Regulation (EU) 2018/1579 and in Annex I of Regulation (EU) 2018/1690 to:

should be read as:	
Sailun Group Co., Ltd	C351

The TARIC additional code C351 previously attributed to Sailun Jinyu Group Co., Ltd shall apply to Sailun Group Co., Ltd
