Information about Denmark's application of the phasing-in period as set out in the Regulation on the EU Digital COVID Certificate (2021/953)

Dear Secretary-General,

The Danish component of the EU Digital COVID Certificate was connected effectively to the EUDCC gateway on 1 June 2021. Since then, Denmark has been issuing EU Digital COVID Certificates to citizens holding a Danish civil registration number.

However, Denmark will not be ready to issue the certificates referred to in Article 3(1) to persons not holding a Danish civil registration number in a format that complies with the Regulation on the EU Digital COVID Certificate (2021/953) from 1 July 2021. Furthermore, Denmark will issue paper-based certificates to some Danish non-digital citizens in a format that will not comply with Regulation on the EU Digital COVID Certificate (2021/953) from 1 July 2021. The Danish authorities expect to be ready to deliver EU Digital COVID Certificates in the format referred to in Article 3(1) to persons not holding a Danish civil registration number and Danish non-digital citizens from at the latest 12 August 2021.

The Danish authorities will issue certificates that contain the necessary data set out in the Annex of the Regulation to EU citizens and residents, and third-country nationals legally staying or residing on the territories of Member States.

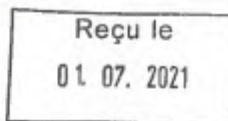

As required under Article 15 of (EU) 2021/953, Ireland is notifying the European Commission and Member States that it is not in a position to start with the issuance of EU Digital COVID Certificates on 1 July 2021.

The utmost priority has been attached to the project under these difficult circumstances, and efforts are ongoing at national level to commence issuing these certificates as soon as possible.

Malta's Notification on the Issuance of Certificates in Compliance with the EU Digital COVID Certificate Regulation

Pursuant to Article 15(2) of Regulation (EU) 2021/953, I am writing to inform you that on Thursday 1 July Malta will effectively connect to the EU Digital COVID Certificate Gateway and will begin to issue vaccination certificates in a format that complies with this Regulation. Vaccination certificates will be issued to those persons who are fully vaccinated with any of the EMA-approved vaccines. Malta intends to issue all types of certificates to meet the requirements of other Member States, however it will only start issuing test and recovery certificates in a format compliant with the Regulation as from 15 July. Furthermore, consistent with the position expressed throughout negotiations on the EU Digital COVID Certificate, given that evidence published to date suggests that reinfection is still possible after initial infection, Malta will not waive restrictions for holders of recovery certificates at this stage.

Pursuant to article 15.2 of Regulation (EU) 2021/953 of the European Parliament and of the Council of 14 June 2021 on a framework for the issuance, verification and acceptance of interoperable COVID-19 vaccination, test and recovery certificates (EU Digital COVID Certificate) to facilitate free movement during the COVID-19 pandemic, Spain hereby informs the Commission and the Member States of its intention to make use of the full period set forth in said article until 12 August 2021, given that certain regions will not be able to issue the test certificates referred to in article 3.1.(b) by 1 July. Therefore, pursuant to article 15.2, Spain asks the other Member States to accept certificates that do not comply with the DCC format during the phasing-in period. As soon as the issuance of this type of certificates can be guaranteed throughout the country, in the format complying with the provisions of the Regulation, this will be duly notified to the Commission and to the Member States.

Information concerning the implementation by Norway of Regulation (EU) 2021/953

Pursuant to Article 15(2) of Regulation (EU) 2021/953, I hereby inform you that Norway has adopted and implemented the regulation in accordance with the provisions set out in the EEA Agreement and has been connected to the EU gateway since 24 June.

At present, EU Digital Corona Certificates in the format set out in Art 3 of the Regulation can be issued to all persons with a Norwegian identification number (ID number) or temporary identification number (D number). This includes vaccine, test and recovery certificates. Non-digital residents can request a certificate in paper-based format.

For other categories of persons, including visitors, a dedicated procedure for the issuance of vaccination and recovery certificates in the format set out in the Regulation is available in paper form. Finally, efforts are underway to ensure that test certificates in full conformity with the regulation (i.e. containing a unique certificate identifier or QR-code) are made available for this last category at the earliest possible opportunity. We expect this to concern only a small number of persons.

We will keep you abreast of developments.
