METROLOGY ACT (CAP. 454)

Metrology (Transposition of Article 6 of Directive 2011/17/EU) **Regulations**, 2022

IN EXERCISE of the powers conferred by article 19 of the Metrology Act, the Minister for Tourism and Consumer Protection, on the advice of the Malta Competition and Consumer Affairs Authority, has made the following regulations:-

The title of these regulations is the Metrology Citation, 1. (1)(Transposition of Article 6 of Directive 2011/17/EU) Regulations, applicability, scope and 2022.

The provisions of these regulations shall be without L.N. 306 of (2)prejudice to the Calibration of Tanks of Inland Waterway Vessels and of Coasters (Revocation) Regulations, 2011, the Standard Mass of Grain (Revocation) Regulations, 2011, the Cold Water Meter (Revocation) Regulations, 2011, the Alcoholometers and Alcoholic Hydrometers (Revocation) Regulations, 2011, the Tyre Pressure L.N. 302 of Gauges (Revocation) Regulations, 2011, the Medium Accuracy Weights (Revocation) Regulations, 2011 and the Weights of Abovemedium Accuracy (Revocation) Regulations, 2011 issued under and 2011. for the purposes of the Metrology Act.

(3)These regulations transpose the requirements of Article 6 of Directive 2011/17/EU of the European Parliament and of the Council of 9 March 2011 repealing Council Directives 71/317/EEC, 71/347/EEC, 71/349/EEC, 74/148/EEC, 75/33/EEC, 76/765/EEC, 76/ 766/EEC and 86/217/EEC regarding metrology.

(4)These regulations shall be deemed to have come into force on the 29th July 2011.
