AUTHORITY FOR TRANSPORT IN MALTA ACT (CAP. 499)

Vessel Traffic Monitoring and Reporting Requirements (Amendment) Regulations, 2019

IN EXERCISE of the powers conferred by article 43(1) and (3) of the Authority for Transport in Malta Act, the Minister for Transport Infrastructure and Capital Projects, after consultation with the Authority for Transport in Malta, has made the following regulations:-

Citation and commencement.

- 1. (1) The title of these regulations is the Vessel Traffic Monitoring and Reporting Requirements (Amendment) Regulations, 2019 and these regulations shall be read and construed as one with the Vessel Traffic Monitoring and Reporting Requirements Regulations, hereinafter referred to as "the principal regulations".
- (2) These regulations shall come into force on 21st December, 2019.

Amends regulation 2 of the principal regulations.

- 2. Sub-regulation (1) of regulation 2 of the principal regulations shall be substituted by the following:
 - "(1) The purpose of these regulations is:
 - (a) to establish, in accordance with the provisions of Directive 2002/59/EC of the European Parliament and of the Council of 27th June 2002, as subsequently amended by Directive 2009/17/EC of the European Parliament and of the Council of 23rd April 2009 and Directive 2011/15/EU of the European Commission of 23rd February 2011, establishing a Community vessel traffic monitoring and information system with a view to enhancing the safety and efficiency of maritime traffic, improving the response of authorities to incidents, accidents or potentially dangerous situations at sea, including search and rescue operations, and contributing to a better prevention and detection of pollution by ships;

- (b) transpose the provisions of Directive 2010/65/EU of the European Parliament and of the Council of 20th October 2010 on reporting formalities for ships arriving in and/or departing from ports of the Member States and repealing Directive 2002/6/E; and
- (c) transpose the provisions of Directive (EU) 2017/2109 of the European Parliament and of the Council of 15th November 2017 amending Council Directive 98/41/EC on the registration of persons sailing on board passenger ships operating to or from ports of the Member States of the Community and Directive 2010/65/EU of the European Parliament and of the Council on reporting formalities for ships arriving in and/or departing from ports of the Member States."
- 3. Sub-regulation (9) of regulation 18 of the principal Amends regulations shall be substituted by the following:
