Notification of a joint venture (Case No IV/35,531 — BT/VIAG)

(95/C 148/03)

(Text with EEA relevance)

- 1. On 2 May 1995, the Commission received a notification of a joint venture pursuant to Article 4 of Council Regulation No 17 (1) formed by British Telecommunications plc (BT) and VIAG Aktiengesellschaft (VIAG). Pursuant to the notified agreement the parties will form a joint venture, to be called VIAG Interkom GmbH & Co. (Interkom).
- 2. BT's principal activity is the provision of telecommunications services and products in the United Kingdom and elsewhere: BT will transfer its German telecommunications business to Interkom. VIAG holds operating companies, primarily in Germany, in the energy, chemicals, packaging, and logistics sectors: VIAG will retain its telecommunications infrastructure and is restricted under the Agreement from selling that network capacity to end users. Interkom will carry out the telecommunications activities of its parent companies in Germany, offering domestic managed network services to customers in Germany as well as the managed network services of Concert, the global alliance between BT and the US long-distance carrier MCI.
- 3. Upon preliminary examination the Commission finds that the notified joint venture could fall within the scope of Regulation No 17.
- 4. The Commission invites interested third parties to submit their possible observations on the operation to the Commission.

Prior notification of a concentration (Case No IV/M.591 — Dow/Buna)

- 1. On 31 May 1995, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EEC) No 4064/89 (¹) by which the undertaking Dow Europe SA, Horgen/Schweiz, belonging to the group The Dow Chemical Company, Delaware/USA acquires within the meaning of Article 3 (1) (b) of Regulation (EEC) No 4064/89 control of 80 % of the undertaking Buna SOW Leuna Olefinverbund GmbH, Berlin/Deutschland by way of purchase of shares. Further shareholder in the undertaking Buna is Bundesanstalt für vereinigungsbedingte Sonderaufgaben (BvS), the former Treuhandanstalt.
- 2. The business activities of the undertakings concerned are:
- for Dow: establishing policies and directing operations of the Dow companies in Europe.
 Dow is producer of commodity petrochemicals, plastics, electrochemicals, consumer specialities such as pharmaceuticals and agricultural chemicals,
- for Buna: production of petrochemicals and electrochemicals.
- 3. Upon preliminary examination, the Commission finds that the notified concentration could fall within the scope of Regulation (EEC) No 4064/89. However, the final decision on this point is reserved.
- 4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.

- 13. The development of methodologies for risk/benefit analyses of materials used in implantable medical devices (test of biocompatibility).

- 14. The development of a method for the determination of the radiodetectability of catheters and other tubular medical devices.
- 15. The development of methods for the determination of the microbial properties of porous packaging materials used in medical applications.
- 16. Test methods to establish conformity to safety standards for equipment used in biotechnology (leaktightness, microbial permeability, cleanability and sterilizability).
- 17. Intercomparison to compare 3 radiometric methods A, B and C for measuring radiant efficiency of gas-fired overhead radiant heaters.
- 18. The validation of a corrosion test for heat exchangers of condensing air heaters.
- 19. The validation of criteria and parameters necessary to ensure the matching of boiler bodies and forced draught burners put separately on the market.
- 20. Analysis of leachates from landfill waste: the validation of standardized methods for the analysis of aqueous leachates.
- 21. The determination of hydrocarbons in water.
- 22. Direct toxicity assessement of complex industrial effluents discharged to sewers.
- 23. The organization of a comparative study to determine the precision of methods of counting staphylococcus aureus, clostridium perfingens, bacillus cereus, listeria monocytogenes and the methods of detection of salmonella and listeria monocytogenes.
- 24. Non-fatty food: multi-method for the determination of pesticides in non-fatty foodstuffs new methods of extraction and new instrumentation.
- 25. The development of a test method to determine the action of disinfectants on materials destined for use in contact with drinking water.
- 26. The development of test methods to evaluate the microbiological deterioration of pipe sealing ring materials.
- 27. Burning behaviour of curtains and drapes: flame spread measurement using a large ignition source.
- The compilation of field measurements on buried pipes and their comparison with estimated design results.
- 29. A method for the evaluation of the fatigue resistance of flexible waterproofing sheets mechanically attached to the structure and subject to dynamic wind flexing.
- Magnetic card readers: test methods and standard tools for the establishment of global requirements for cards and IC systems.

Category II: Subjects related to the standardization activities of ETSI

- 31. The development of ISO 9646 type approval test tools for GSM (phase 2).
- 32. The development of measurement, testing and calibration procedures for mobile radio channel test equipment.

Scientific merit will be the overriding criterion in the evaluation and selection of projects.

Activity 3: Training through research

This activity will concentrate on the training of European researchers at the post-doctoral level through research and through the stimulation of their mobility.

This activity will be implemented through 3 types of grant: grants for training, return grants, and grants to established researchers.

A. Grants for training

These grants are offered to post-doctoral researchers who wish to receive training or to specialize outside the country of their nationality and their country of recent residence. A post-doctoral researcher is defined as a researcher holding either a doctoral degree or equivalent level of education or, alternatively, having at least 4 years' full-time research experience at post-graduate level.

Training grants may also be offered to post-graduate researchers. A post-graduate researcher is defined as a holder of a degree, obtained from a university or equivalent institution of higher education, which qualifies the holder directly to embark on a doctorate or equivalent degree.

Community support will provide, for a period of between 6 months and 2 years at post-doctoral level and between 6 months and 3 years at post-graduate level, an allowance for the researcher and a contribution to the research and administrative costs of the host institute.

B. Return grants

Return grants are reserved for researchers from less-favoured regions who wish to return and undertake

research in a less-favoured region in the country of their nationality and who:

 have been in receipt of a full 2-year post-doctoral grant for training under this programme;

or

 have been in receipt of a post-doctoral fellowship of at least 20 months under the HCM programme.

Community support will provide, for a period of up to 12 months, an allowance for the researcher and a contribution to the research and administrative costs of the host institute.

C. Grants to established researchers

These grants are reserved for established researchers, particularly from industrialized regions, who wish to join a research team in the less-favoured regions outside the country of their nationality, in order to impart their knowledge and research experience. Applicants for these grants should have at least 8 years' full-time research experience at post-graduate level.

Community support will provide, for a period of 3 months to 1 year, an allowance for the researcher and a contribution to the research and administrative costs of the host institute.

Project proposals for training through research (A. grants for training, B. return grants, C. grants to established researchers) must arrive at the Commission by 15. 9. 1995 (12.00).

Activity 4: Accompanying measures (euroconferences, summer schools and practical training courses)

Euroconferences are to be high-level scientific meetings with a focused theme at the cutting-edge of research bringing together young researchers and and established scientists. A euroconference project would normally be a series of meetings, each lasting for several days and taking place in a closed environment. The number of participants will normally be between 30 and 100.

Summer schools are to provide advanced training for young researchers at post-graduate and post-doctoral level. Summer schools are to be organized around specific scientific themes and will have a defined syllabus; interdisciplinary summer schools are encouraged.

Practical training courses are to be advanced courses organized in research institutes, scientific centres, or industrial laboratories with an emphasis on practical techniques and substantial hands-on or field experience for the participants.

The Community financing may not be considered as a general subsidy; it may be used as a contribution to 3 types of expenses: (A) expenses related to the participation of young scientists; (B) up to 50 % of the expenses related to the participation of invited keynote speakers and scientific organizers; (C) expenses related to organization.

Project proposals for accompanying measures (euroconferences, summer schools and practical training courses) must arrive at the Commission by 2. 10. 1995 (12.00).
