Notification of book price agreements in the German language area

(Case No IV/34.657 — Sammelrevers)

(96/C 54/02)

(Text with EEA relevance)

1. On 18 March 1993, the editors Manzsche Verlags- und Universitätsbuchhandlung, Nomos Verlagsgesellschaft and Droemersche Verlagsgesellschaft Th. Knaur Nachf. notified to the Commission an agreement for the fixing of retail prices for print products in Germany and Austria (Sammelrevers), pursuant to Article 4 of Council Regulation No 17 (¹). On 7 October 1993, numerous other editors active in Germany and Austria joined this notification.

2. The notification concerns agreements between German editors and Austrian booksellers, between Austrian editors and German booksellers, as well as between German editors and German booksellers and between Austrian editors and Austrian booksellers. The conclusion of these retail price-fixing agreements and their control are managed in a centralized form by special agents (Preisbindungstreuhänder). The price fixing for seven large German editors (Einzelreverse) is organized through a procedure which is separate from that of the Sammelrevers.

3. On 29 July 1994, the Directorate-General for Competition issued a comfort letter that exempted the Sammelrevers system from the application of the prohibition of restrictive practices under Article 85 (1) of the EC Treaty, albeit on a provisional basis and for a period of time until 30 June 1996. On 6 January 1995, a further comfort letter was issued in relation to the Einzelrevers, on the same terms as for the Sammelrevers. The comfort letters were the result of a provisional examination and were intended to create legal certainty for the parties concerned. They do not represent the definitive position of the Commission on the question of whether or not the conditions for an exemption under Article 85 (3) of the EC Treaty are fulfilled. This will be the object of a formal decision of the Commission which is presently in preparation.

4. The Commission gives interested parties the opportunity to comment on the retail pricefixing system for books under the names of Sammelrevers and Einzelrevers. These comments are covered by the rules on professional secrecy in accordance with Article 20 of Regulation No 17. Proposal for a Council Regulation amending Regulation (EEC) No 1602/92 temporarily derogating from implementation of Community anti-dumping measures on imports into the Canary Islands of certain sensitive products

(96/C 54/05)

(Submitted by the Commission on 11 December 1995)

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament,

Whereas Regulation (EEC) No 1602/92 (¹) introduced special measures for applying anti-dumping duties to imports into the Canary Islands of certain sensitive products; whereas these measures are designed to ensure optimum conditions for the supply of these products, to take account of particular problems in a given sector of local production intended for local consumption or tourism, and/or to allow access for consumer goods;

Whereas the special arrangements set out in Article 1 (2) and Annex II to Regulation (EEC) No 1602/92 provide for full exemption from anti-dumping duties from 1 July 1991 to 31 December 1995, and the gradual increase of anti-dumping duties by 20 % per year from 1 January 1996, to become payable in full on 1 January 2000;

Whereas by letter of November 1995, the Spanish authorities requested that the first period of full exemption from payment of anti-dumping duties should be extended for another year so that the gradual collection of these duties should not start until 1 January 1997; whereas a similar extension is proposed with respect to the suspension of the Common Customs Tariff duties on imports of the same products into the Canary Islands under Council Regulation (EEC) No 1605/92 (²) of 15 June 1992; Whereas it seems appropriate to allow operators in the Canary Islands an additional year to adjust to the new tariff arrangements being introduced;

Whereas it entails a simple alteration to the timetable contained in the special arrangements for anti-dumping duties within the transitional period expiring on 31 December 2000 laid down by Article 6 of Council Regulation (EEC) No 1911/91 (³) of 26 June 1991 on the application of the provisions of Community law to the Canary Islands;

Whereas Article 1 (2) and Annex II to Regulation (EEC) No 1602/92 should be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

Article 1 (2) of Regulation (EEC) No 1602/92 is replaced by the following:

'Under the specific arrangements referred to in paragraph 1:

- from 1 July 1991 to 31 December 1996, full exemption from anti-dumping duties shall be granted;
- from 1 January 1997, collection shall be gradually increased in accordance with the details given in Annex II.'

Article 2

In Annex II to Regulation (EEC) No 1602/92, the timetable for the gradual collection of anti-dumping duties payable on import into the Canary Islands of products listed in Annex I is replaced by the following timetable.
