The Commission has installed a telex with an automatic answering device which gives the conversion rates in a number of currencies. This service is available every day from 3.30 p.m. until 1 p.m. the following day. Users of the service should do as follows:

Prior notification of a concentration (Case No IV/M.727 — BP/Mobil)

- 1. On 5 July 1996, the Commission received notification of a proposed concentration pursuant to Article 4 of Council Regulation (EEC) No 4064/89 (¹) by which BP Company plc (BP) and Mobil Corporation (Mobil) acquire within the meaning of Article 3 (1) (b) of the Regulation joint control of a newly created company constituting a joint venture.
- 2. The business activities of the undertakings concerned are:
- BP: oil and gas exploration and production, refining, marketing, supply and transportation
 of oil and oil products and manufacturing and marketing of petrochemicals,
- Mobil: oil and gas exploration and production, refining, marketing, supply and transportation of oil and oil products and manufacturing and marketing of petrochemicals, speciality products and plastic-packaging films.
- 3. On preliminary examination, the Commission finds that the notified concentration could fall within the scope of Regulation (EEC) No 4064/89. However, the final decision on this point is reserved.
- 4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.

Commission notice pursuant to Article 93 (2) of the EC Treaty to Member States and other interested parties on aid that Italy (Lazio) has decided to grant cooperatives and farms in difficulty

In the letter reproduced below, the Commission informed the Italian Government of its decision to close the Article 93 (2) procedure of the Treaty opened on this aid.

2. Law No 52/94 was amended by the Lazio Region on 19 January 1996. As a result of the amendments:

'By letter of 14 July 1994, the Italian Permanent Representation to the European Union notified the Commission, referring to Article 93 (3) of the Treaty, of the regional law covering the abovementioned aid.

By letter dated 31 May 1995, the Italian authorities provided additional information in response to Commission requests of 8 August and 10 November 1994.

The law in question was amended and readopted on 14 September 1994 and published under the number 52 on 31 October 1994.

The Commission, by letter dated 7 November 1995, opened for the aid covered by the said law the procedure provided for in Article 93 (2) of the Treaty and gave the Italian Government notice to submit its comments.

Other Member States and interested parties were also given notice to submit their comments (1).

No comments were received from any other Member State or any other party.

By letters of 15 December 1995 and 12, 21 and 28 February 1996, the Italian authorities provided the following information:

1. No aid has been granted under Regional Law No 52 of 31 October 1994.

- the aid of up to 50% of debts entered on the balance sheets of cooperatives and consortia in cases of merger between such bodies (Article 4 (1)) has been deleted,
- the debt consolidation aid for cooperatives and consortia (Article 1 (1)) will, as already stipulated for aid to farms (Article 1 (2)), be granted only to consolidate heavy debts incurred as a result of investments made.
- 3. Aid, granted in the form of an interest rebate, will be authorized in regard to at most 80% of the investment in the case of cooperatives and 65% in the case of farms. On the basis of the calculations notified by the Italian authorities it will not exceed 35% of the eligible investment.

The Italian authorities have undertaken not to exceed the rates normally allowed by the Commission for the aggregate subsidy equivalent of any aid granted when the loans were taken out plus the aid in question, namely 35 % in the case of investment in primary agricultural production (75 % in less favoured areas listed in Directive 75/268/EEC) and 55 % for investment in processing and marketing of agricultural products. The authorities confirm that the investments made respected the sectoral limits set by the Commission applying at the time while the decision to aid them was taken.

4. Aid will be granted only to cooperatives and farms in difficulties that can offer viability guarantees, particularly in cases where the financial burdens resulting from existing borrowings are such that the farm is at risk, possibly of bankruptcy.

On these terms the aid in question meets the Commission's criteria for this type of aid and can therefore be considered permissible under Article 92 (3)

(c) of the Treaty as aid to facilitate the development of certain economic activities or of certain economic areas that does not adversely affect trade to an extent contrary to the common interest.

The Commission has accordingly decided to close the procedure indicated in Article 93 (2) of the EC Treaty for the measures in question.'
