— *Measure C5.1.3.c — Water management and rationalisation of water resources.*

An increase of EUR 10 406 396 is planned for this measure, which involves investment aid to agricultural undertakings and aid for infrastructural works by land improvement consortia.

— *Measure C5.1.4 — Slurry management plan and structural assistance for animal production.*

An increase of EUR 22 264 354 is planned for this measure, which involves investment aid for livestock holdings.

— *Measure C5.1.5 — Management of agricultural practices: eco-friendly environmental innovation.*

A increase of EUR 1 500 000 is planned for this measure, which involves the application and/or consolidation of new techniques, including the revival of traditional practices, and new organic farming practices
