The details of this public service obligation have been published in the 'Official Journal of the European Union' C 316 of 22.12.2006.

If, by 25.2.2007, no EU air carrier has submitted to the Ministerium für Verkehr, Bau und Landesentwicklung Mecklenburg-Vorpommern written proof of commencement of air services with effect from 25.3.2007 in accordance with the public service obligation imposed and without requesting compensation, Germany will, under the procedure laid down in Article 4(1)(d) of the abovementioned Regulation, limit access to a single air carrier and put out the right to operate such services from 25.3.2007 to public tender.

- 2. **Subject of the invitation to tender:** Operation of scheduled air services between Rostock-Laage and Munich in accordance with the public service obligation imposed on this route, as published in the 'Official Journal of the European Union' C 316 of 22.12.2006.
