1. On 22 December 2009, the Commission received notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004⁽¹⁾ by which the undertakings Robert Bosch GmbH ('Bosch', Germany), Deutz Abgastechnik GmbH ('Deutz', Germany) and Eberspächer GmbH & Co. KG ('Eberspächer', Germany) create and jointly control a new full-function joint venture in the areas of complete diesel exhaust after-treatment systems for both non-road mobile machinery and special utility vehicles manufactured in a small batch series as well as active regeneration of diesel soot particle filters.
2. The business activities of the undertakings concerned are:
 - for Bosch: automotive engineering, industrial engineering, consumable goods engineering as well as building services engineering (worldwide),
 - for Deutz: diesel engines (worldwide),
 - for Eberspächer: exhaust technology and vehicle heaters (worldwide).
3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of Regulation (EC) No 139/2004. However, the final decision on this point is reserved.
4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.
