The European Medicines Agency (EMA) wishes to set up a roster of candidates interested to work for temporary assignments under the contract agent contract. The job profiles are published in a separate document available on the Agency's website.

The contract agent contract can only lead to a temporary agent contract with the successful participation in an additional selection procedure. Contract agent contracts may not be renewed more than once.
