Arrêtent:

Art. 1^{er}. — Les dispositions de l'avenant (1) à l'accord interprofessionnel susvisé, relatif au montant de la cotisation, conclu dans le cadre de l'Association nationale interprofessionnelle et technique du tabac (ANITTA) sont étendues pour l'année 2011 à tous les membres des professions constituant cette organisation interprofessionnelle.

Art. 2. — Conformément à l'article 9, paragraphe 2, du règlement (CE) n° 709/2008 susvisé, la mesure de l'article 1^{er} prend effet deux mois après la date de publication au *Journal officiel de l'Union européenne*, série C.

Art. 3. — La directrice générale de la concurrence, de la consommation et de la répression des fraudes au ministère de l'économie, des finances et de l'industrie et le directeur général des politiques agricole, agroalimentaire et des territoires au ministère de l'agriculture, de l'alimentation, de la pêche, de la ruralité et de l'aménagement du territoire sont chargés, chacun en ce qui le concerne, de l'exécution du présent arrêté, qui sera publié au *Journal officiel de la République française*.

On 1 August 2011, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004⁽¹⁾ by which UPM-Kymmene Corporation ('UPM', Finland) acquires within the meaning of Article 3 (1) (b) of the Merger Regulation sole control of the whole Myllykoski Paper Oy ('Myllykosky Paper', Finland), by way of purchase of shares. As a result of the notified transaction, UPM will acquire the 35 % stake in Myllykoski Paper, currently held by M-real Corporation (M-real). The remaining 65 % of the shares in Myllykoski Paper are owned by UPM following its acquisition of Myllykoski Corporation ('Myllykoski') on 1 August 2011.

2. The business activities of the undertakings concerned are:

- For UPM-Kymmene Corporation: development, production and marketing of paper products. It also produces pulp electricity, sawn timber and wood panel products,
- For Myllykosky Paper Oy: production of paper products.

3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of the EC Merger Regulation. However, the final decision on this point is reserved. Pursuant to the Commission Notice on a simplified procedure for treatment of certain concentrations under the EC Merger Regulation⁽²⁾ it should be noted that this case is a candidate for treatment under the procedure set out in the Notice.
