The European Medicines Agency (EMA) wishes to set up a roster of candidates interested to work for temporary assignments under the contract agent contract. The job profile is published in a separate document available on the Agency's website.

Selected candidates will be included on a reserve list and, depending on the budgetary situation, may be offered a temporary assignment which can range from 3 months to 5 years under the contract agent contract in accordance with the Conditions of Employment of Other Servants of the European Union (OJ L 56, 4.3.1968) ⁽¹⁾ and EMA's general implementing provisions on the procedures governing the engagement and the use of contract staff at EMA.

A temporary assignment may include replacements of EMA temporary agents (for example maternity leave, paternity leave, family leave, parental leave, unpaid leave or long-term sickness) or to work on specific short-term projects. The contract agent contract can only lead to a temporary agent contract with the successful participation in an additional selection procedure. Contract agent contracts may not be renewed more than once.

The place of employment shall be Canary Wharf, London.

Candidates must be nationals of a Member State of the European Union, or of Iceland, Liechtenstein or Norway, on condition that they have full rights as a citizen.

Candidates must have fulfilled any obligations imposed on them by laws concerning military service and meet the character requirements for the duties involved.
