- BSN Medical: a medical device company that develops, manufactures and markets wound care, compression therapy and orthopedics products.
- 3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope the EC Merger Regulation. However, the final decision on this point is reserved.
