RECRUITMENT FOR THE EUROPEAN MEDICINES AGENCY (LONDON)

(2013/C 166 A/01)

The Agency is responsible for co-ordinating the evaluation and supervision of medicinal products for human and veterinary use in the European Union (see Regulation (EC) No 726/2004 of the European Parliament and of the Council — OJ L 136, 30.4.2004, p. 1). The Agency was established in January 1995. It has many close contacts with the European Commission, the 27 EU Member States, the EEA-EFTA countries and many other groups in government and the private sector.

The European Medicines Agency is organising a selection procedure with a view to drawing up a reserve list for:

EMA/AD/350: Administrator (Scientific), Quality of Medicines, Human Medicines Development and Evaluation Unit (AD 6).

EMA/AST/351: Resourcing Assistant, IT Office, Information and Communications Technology Unit (AST 3).

EMA/AD/352: Scientific Administrator, Veterinary Medicines Sector, Veterinary Medicines and Product Data Management unit (AD 6).

Selected candidates will be included on a reserve list and, depending on the budgetary situation, may be offered a five-year renewable contract in accordance with the Conditions of employment of other servants of the European Union (OJ L 56, 4.3.1968).

The place of employment shall be London.

Candidates must be nationals of a Member State of the European Union, or of Iceland, Liechtenstein or Norway, on condition that they have full rights as a citizen.
